This includes any statement made herein which is knowingly incorrect, incomplete or misleading in any important particular.
3. Submission of this form does NOT guarantee an opportunity to present a paper at the Military Operations Research Society Symposium, special meeting or workshop. Such invitation will be issued separately.
4. Fill in all the blanks. If Form 712AU is not complete, it will be sent back for completion.
5. Form 712AU shall be originated by the author who fills in and signs **Part I** and attaches an Unclassified paragraph abstract.
6. The Contractor Security Officer completes **Part II** and forwards it to the cognizant Government Contracting Officer.
7. The cognizant Government Contracting Officer or Study Sponsor fills in **Part III** of form 712AU and forwards it to the address below.
